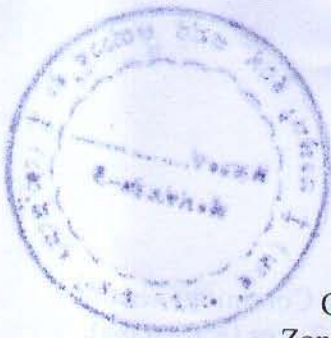

They are informed that the participants are invariably registered dealers at outside the State under the relevant State Vat Acts and therefore they can transport goods for purposes of display in the exhibition on the strength of documents prescribed under the Sales Tax / VAT Laws of the concerned State showing the consignors as themselves and consignee as self. Participants from outside the country can cause the entry of goods to the exhibition venue on the strength of Bill of Entry and other customs clearance documents. Therefore, the question of granting permission for the transportation of goods does not arise.
